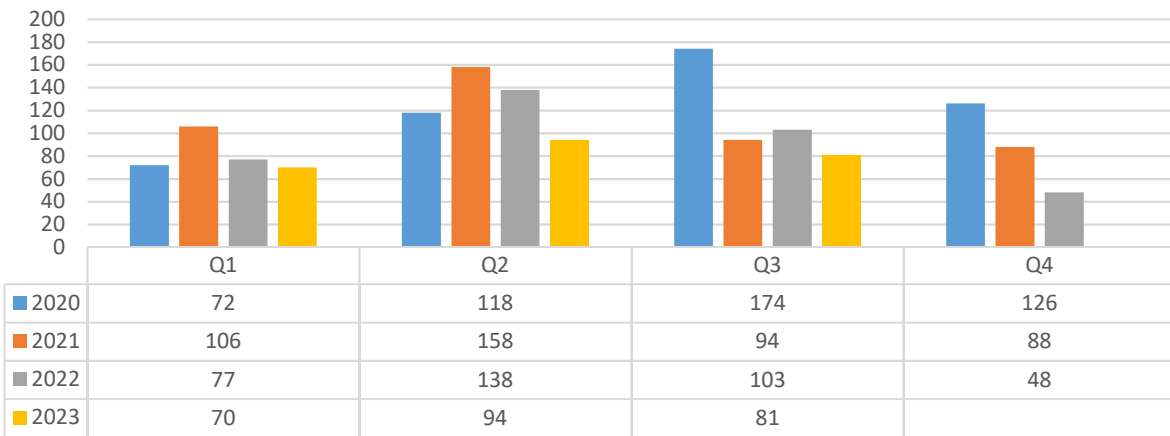

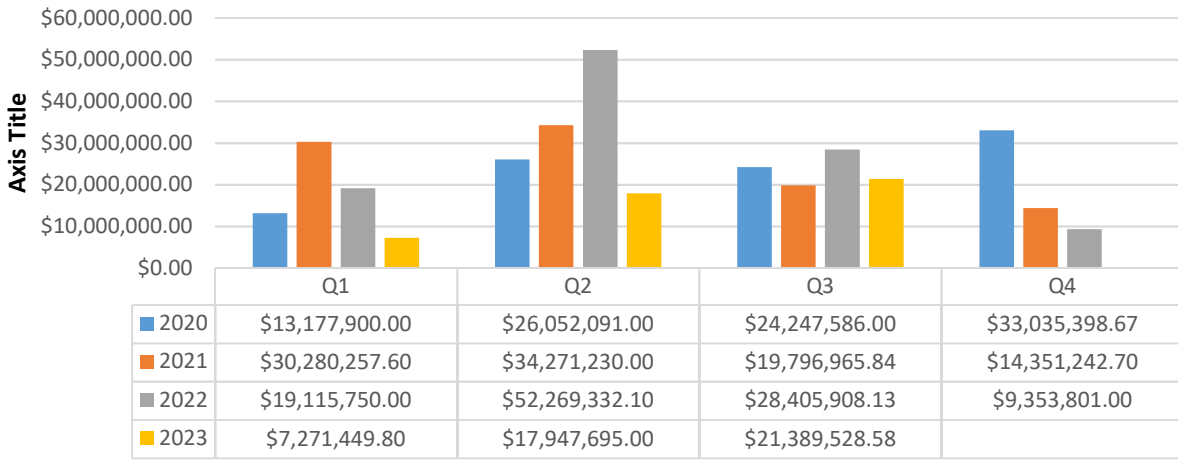

Construction Value of Permits Issued

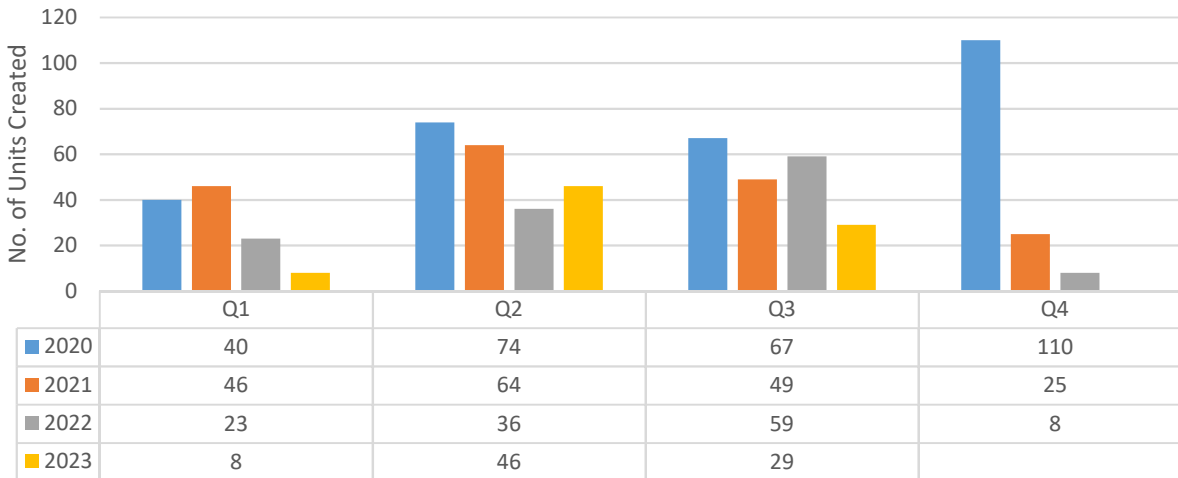

Type	Description
Single Detached Dwelling	New purpose built house with one dwelling unit
Two Dwelling Unit Residential	New purpose built two dwelling unit (semi-detached or duplex)
Townhouse	New conventional row housing
Multi-Unit Residential (3+ Units)	New purpose built residential building with 3+ dwelling units, including stacked townhouses
Additional Residential Unit	Additional residential units created in an existing house or accessory building
Other New Residential Dwelling	Creation of one or more residential apartment units in an existing building or creation of two or fewer residential units in a new mixed use building (typically commercial/residential buildings).
Season Farm Worker Dwelling/Bunkhouse	Construction of a new seasonal farm worker dwelling

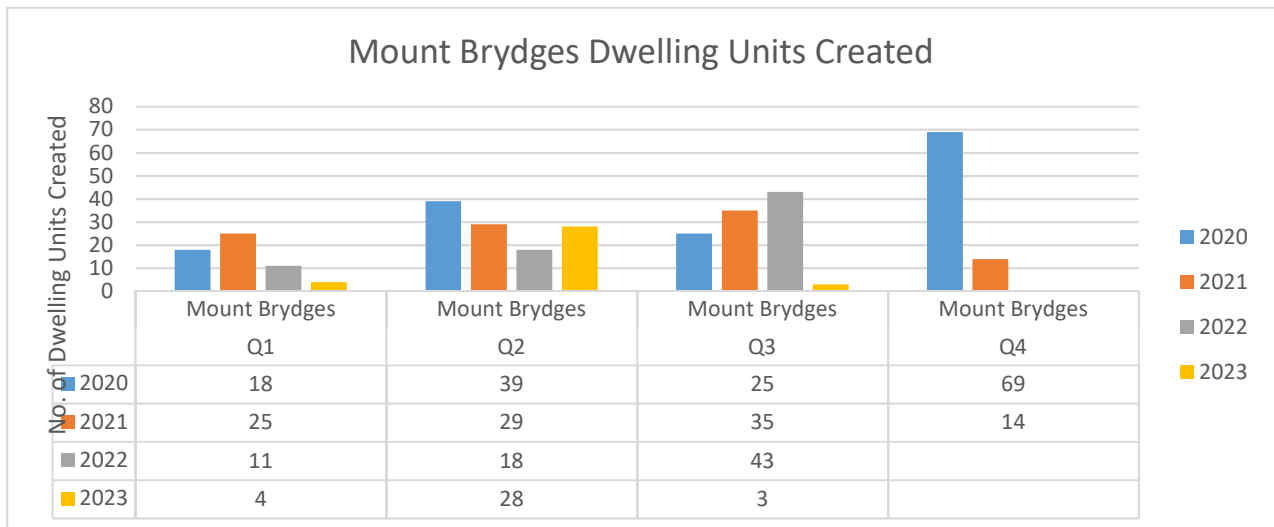

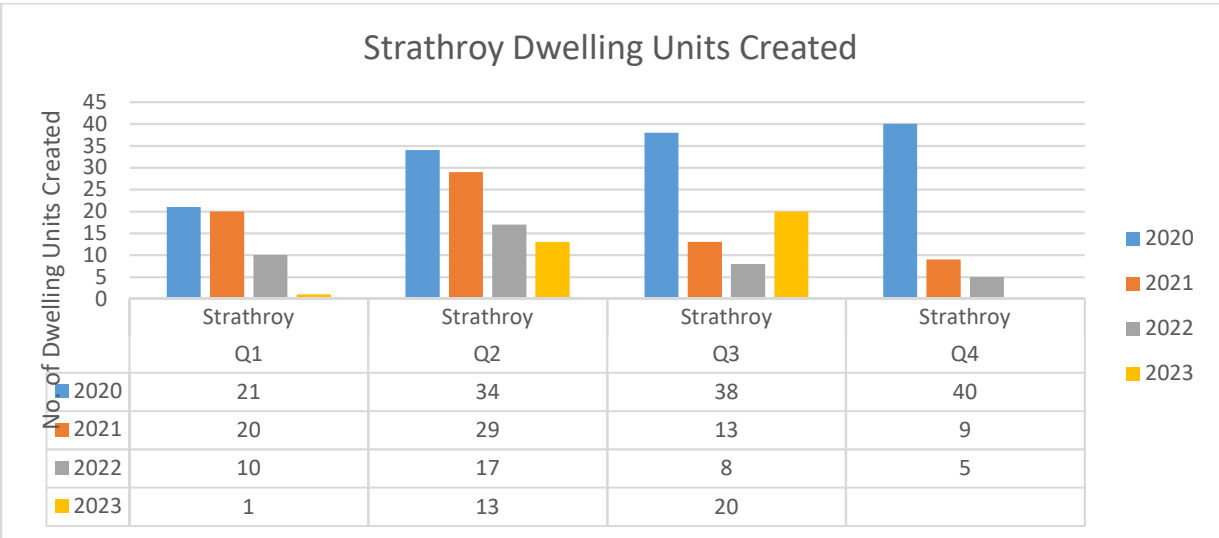
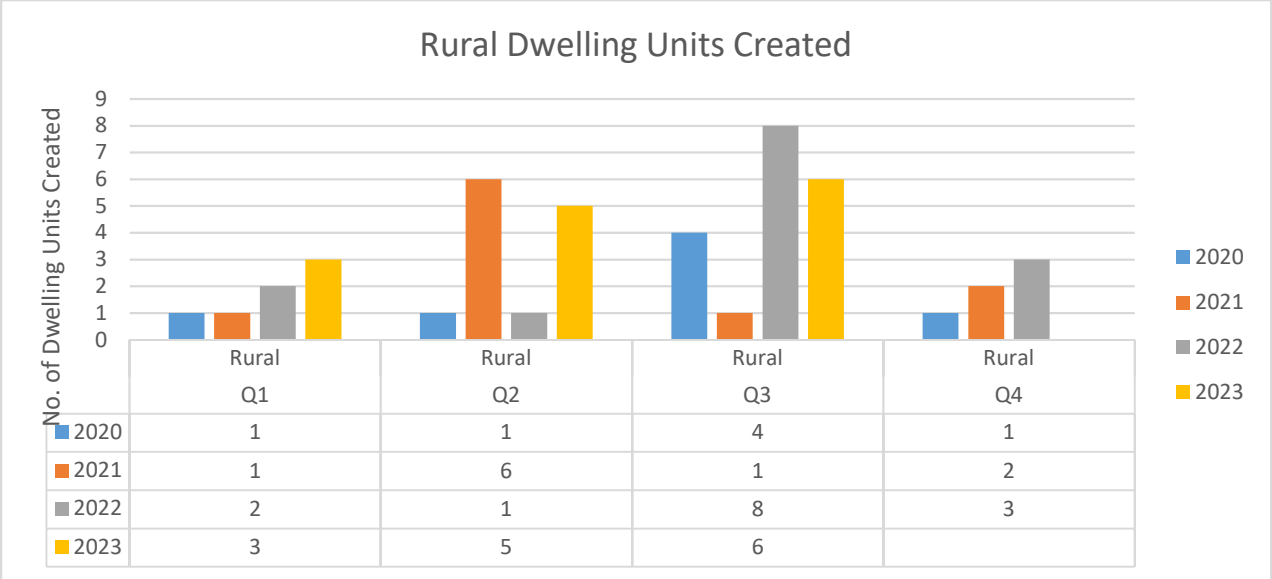
