Note: Applicant must be the person supervising the firing of the fireworks and those doing the firing must not be under 18 years of age.

The following conditions shall apply to the holding of a display of display fireworks under a permit issued under this by-law:

- a) the permit is valid only for the display at the place and on the date or dates set forth in the permit;
- b) the permit holder shall supervise the display of display fireworks;
- c) the permit holder shall discharge the display fireworks and any consumer fireworks;
- d) every permit holder shall provide and maintain fully operational, fire extinguishing equipment ready for immediate use;
- e) the permit holder shall comply at all times with the provisions of the Act, FPPA and the Display Fireworks Manual published by Natural Resources Canada or any successor publication;
- f) No permit holder shall discharge display fireworks or consumer fireworks except in accordance with the conditions of the permit; and
- g) The permit holder holding the display of display fireworks shall ensure that all unused fireworks and all debris are removed, in compliance with the Act, FPPA and the Display Fireworks Manual published by Natural Resources Canada or any successor publication.
