### **INSTRUCTIONS**

This process pertains to an application for Part Lot Control Exemption pursuant to Section 50 of the Planning Act. Prior to the Municipality processing the application, it is required that a copy (1) of the attached application form be **COMPLETED** including the reference plan illustrating the details of your request, and the processing fees of:

Part Lot Control Exemption application fee: \$750.00

#### PLEASE NOTE

- The application must be completed in metric units.
- Applicants should be aware that receipt of inaccurate information may cause delays in the hearing of the application.
- The County of Middlesex is the approval authority for part lot control exemption.
