

Instructions for Street Naming Request Application

BACKGROUND INFORMATION

The submission of a Street Naming Request Application is required for all requests to name a street within Strathroy-Caradoc. A Street is any existing or proposed public or private street, lane or walkway within the boundaries of the Municipality of Strathroy-Caradoc.

Prior to the Municipality processing the application, it is required that a copy (1) of the attached application form be **COMPLETED**, and submitted along with the required documentation and processing fee of:

Application fee: \$300.00.
